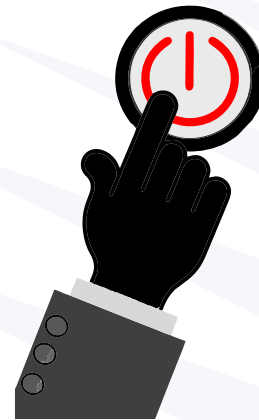
New Year Mega Lottery will payback all investors from the proceeds from sales of Lottery Tickets . Repayment shall be done installmentally; on quarterly basis.


